In times of normality, the right to freedom of religion or belief is taken for granted by the majority of people in Europe. During the pandemic, European governments reacted in various ways by limiting the right to freedom of religion or belief. Some traditions like the Orthodox one, the practice of the 'shared spoon' (a centuries-old practice for the receiving of communion) raised questions on whether communion is source of health or source of disease. Dr Goran Gunner, Church of Sweden and Uniting Church in Sweden</li> </ul>	<p style="text-align: center;"><b><u>Webinar 7</u></b> <b>15:00-16:30</b></p> <p style="text-align: center;"><b>Monitoring the rule of law in times of Covid-19: The enhanced rule of law mechanism as a more promising approach to a value-based Europe?</b></p> <p>The gradual erosion of the rule of law has been promoted by the unprecedented Covid-19 pandemic. In her agenda for Europe Commission President Ursula von der Leyen underlined that “there can be no compromise when it comes to defending our core values”. She announced to support an additional comprehensive European Rule of Law Mechanism, with an EU-wide scope. Hence, the European Commission has declared to enhance its monitoring of the rule of law in EU member States through a rule of law review cycle. The cornerstone of the initiative is an objective annual report assessing the rule of law situation in all EU member States in order to reflect the idea of a real community of values. The report is to be issued by the European Commission for the first time in September 2020 building on a proposal first advanced by the German and Belgian foreign ministers in 2019. Promoting the rule of law, democracy and fundamental rights is an aim which is among the key priorities of the German Council Presidency starting on July 1.</p> <p>What are the expectations with regard to this new rule of law initiative?
